Open for business—but differently

The Foundation is continuing to operate, but from a non-public location. Our Blende St office will open by appointment only, with contact through 08 8087 9985, mobile 0429 695 399 or email manager@foundationbh.org.au

The Board has been meeting weekly via the ZOOM online application to keep abreast of local challenges and opportunities. Our Finance subcommittee has also been meeting weekly to monitor investments and confirm our strategy moving forward.

Client loan repayments

A first step was to contact our project clients to identify what impact the virus and associated contact restrictions was having on their business and then to offer a sabbatical in loan repayments to those currently funded to establish or expand in order to create new local employment opportunities.

Three unfortunately had to temporarily close as a result of Covid-19 and took the option to defer repaying their loans for at least three months, one needed to defer for longer because it couldn't start the project funded and another paid up its loan because it could no longer commit to doing the work planned. Another six felt they could continue for now, but all appreciated our flexibility.

Practical local support

At the end of March the Barrier Daily Truth (BDT) announced it would no longer be able to publish a local newspaper and attributed this to a dramatic fall in advertising due to restrictions under the Covid-19 response guidelines.

The Foundation committed funds from our Project Account to join others in supporting the BDT with advertising so it could at least reinstate a weekly publication.

Our 'double-dip' is to pay for local businesses to have free ads in the paper, particularly to promote changes resulting from restrictions.



The free ads have been gratefully accepted by 15 businesses to date, with more waiting for the next issue.



External funding bid

The Foundation continues, as always, to seek external funding for Broken Hill but is now focussed on accessing funds to come from the national response to economic recovery from the Covid-19 pandemic.

Despite the 'busyness' of the last few months, it has been my great pleasure to take time to chat with Andrew Schmidt on ABC Radio and Mike Herd on 2BH Broken Hill about the Foundation.

We are always conscious of our need to increase awareness in the regional community about our objectives and the work we do to achieve our goals. Both Andrew and Mike were interested in the beginnings of the Foundation and our achievements over 20 years to help Broken Hill diversify the local economy to prepare for a life after mining.

These conversations have been held weekly and resulted in very positive feedback. Now it's time to pass the baton.

Alliance focuses on Covid-19

The Broken Hill Alliance initiated by the Foundation last year (to ensure collaboration among local leadership groups) has recently expanded and developed a specific focus on supporting businesses impacted by Covid-19.

With an estimated local job loss of 539 and associated revenue loss of more than \$400,000, the Alliance has been meeting weekly to identify opportunities to turn this around in the recovery period.

Initial Alliance members included the Foundation (with Foundation Director Karren Howe as Chair); City Council; RDA Far West; #25in25; and representatives from the NSW Department of Premier and Cabinet.

The group has expanded to include BEC Business Advice; Broken Hill Landcare; and ABC Radio

Recent steps have included a survey of local businesses to identify specific impacts and support needs (135 participants) and working collaboratively to develop a one-stop-shop to access relevant, concise and accurate information about supports available from all levels of government and other organisations.

The iconic Bells Milk Bar is on the move!

There's no need for alarm—
Australia's oldest remaining milk bar is staying right where it is at 160
Patton Street South Broken Hill.

However, current proprietor Jason King is about to embark on a business development plan to ensure the traditional milkshakes and unique fizzy spiders are available to tourist and residents right across the city.

Jason has acquired a 1960s Morris ice cream van that, with some quite dramatic restoration, will take Bells' iconic drinks to the masses on the north side of the city and add to the gala of local events patronised by tourists. He hopes to have the vehicle ready for action by summer.

Foundation Broken Hill is delighted to be able to assist Jason in this goal, by providing an interest-free loan to offset establishment costs.

Jason's previous ventures have set Bells up as an intact 1950s Milk Bar and created a milk bar museum to delight visitors. There are still some hurdles to overcome for the mobile side of the business, but the Board feels confident Jason's drive and

repayments and some flexibility as the project progresses. This allows recycled funds to support other businesses (or perhaps another expansion application from Jason down the track).

Foundation Broken Hill: How it works...

Foundation Broken Hill facilitates employment opportunities and encourages social development in Broken Hill and the surrounding region. Its core function is to help Broken Hill create sustainable alternative businesses to replace mining industry jobs as the ore bodies are progressively exhausted.

The Foundation Board comprises a set of highly skilled people with diverse expertise, who give their time voluntarily for community benefit. We do this by:

 Raising capital funds... through fundraising campaigns which seek donations from current and former Broken Hill residents, local businesses, broader industry and governments,

- 2. Recognising contributions...
- through a structured Friends of the Foundation pyramid at Platinum, Gold, Silver and Zinc levels, with opportunity for smaller once-only donations too,
- Investing the capital... to generate funds for approved projects, taking care to ensure our contributors' money is protected so that it works for Broken Hill in perpetuity,
- 4. Carefully assessing applications for funding support... through a thorough process that includes documentation review, business planning assessments, face-to-face discussion and site visits where relevant,
- 5. Providing support... in appropriate forms, which can include once-only small grants or larger interest-free loans repayable over a longer term with flexible sustainable payment plans and some 'breathing space' for new or emerging businesses,
- Monitoring and reviewing...
 businesses who have received
 support to identify whether
 additional assistance is required,
 including mentoring.

Foundation Broken Hill has been operating in the local community for more than 20 years and is now sustainable in its own right. It needs support to grow the Capital Fund so it can increase more meaningful contributions to the community.
